THE FOUNDATION MAINTAINED AND IMPROVED THE CAMP'S FACILITIES: FIVE VILLAGES THAT COULD HOUSE OVER 300 YOUNG PEOPLE, ROPES COURSE, CLIMBING TOWER, ZIP LINE, ARCHERY AND SHOOTING RANGE, A SWIMMING POOL, AND TORNADO SHELTER. FOUNDATION SUPPORT ALLOWED 4-H YOUTH TO USE THE CAMP FOR OUTDOOR ACTIVITIES AND PROGRAMS, ACCESSING HIKING TRAILS, A POND, AND OUTDOOR ADVENTURES ON 1,000 ACRES ALONG THE DES MOINES RIVER. THE CAMP PROPERTY WAS SOLD IN DECEMBER 2019.
